The CASoft software is distributed as freeware, which means that it can be used freely. The freeware status allows the authors to release a complete (or partial) version of the software that can be used without requiring any fee to be paid.

By using any part of the software, you accept all the terms and conditions of the present license agreement. If you disagree with the terms of the present license agreement, please do not download, install, copy or use the software.

DEFINITION OF CASOFT SOFTWARE

The CASoft Software is the joint production and property of:

- Laboratoire National de métrologie et d'Essais (LNE, France),
- National Physical Laboratory (NPL, UK), and
- Research Institutes of Sweden (RISE, Sweden).

It comprises an executable, a user manual and example files.

AUTHOR RIGHTS

The CASoft software is protected by author rights. The owners of the author rights reserve for themselves the exclusive rights on the software, except those granted by the present agreement.

DESCRIPTION OF OTHER RIGHTS AND RESTRICTIONS
